Member Information

1. Membership fees are non-refundable.
2. Membership fees will remain constant throughout the specified term of the membership. Renewal notices will be mailed. Membership term is the First Weekend in April to the Last Weekend in October.
3. For initial membership to be valid, a signed membership agreement is required and dues are payable in full.
4. CampOut reserves the right to terminate the membership if the policies and/or terms of the agreement are violated.
5. Membership will terminate automatically if the appropriate dues have not been paid on or before the specified anniversary date.

Member Policies

1. Camping Space is first-come, first served. No permanent tent sites are allowed.
2. At no time will any person or group occupy the campground or cabins for longer than 7 consecutive days.
3. Open fires are only allowed in the main fire circle or specified group sites.
4. Smoking is allowed outdoors only. No smoking in any building including the Pavilion and Porta Potties.
5. Memberships will be terminated for illegal drug use on the property.
6. Pets are not allowed at the Music Festival or Wild Western Women's Weekend or any other specified special event. At any other time, pets must be under complete voice control or on a leash at all times. Pets are allowed in designated cabin. Pets must be kept quiet and owners must clean up after their pet. Pets are allowed to swim at the lake, but must stay off the beach area.
7. All female children and male children under the age of 6 are welcome. No male children over the age of 5 are allowed except on the designated family weekends. Memberships will not be available to children under 13 years of age. At age 13, female children will pay adult fees and will be required to purchase a membership.

Waiver of Liability Claim

As a member, I understand that CampOut representatives design programs throughout the year involving various levels of physical activity. It is my responsibility to be aware of the level of physical activity involved and to make sure it is suitable for my state of health. CampOut assumes no responsibility for injury or illness caused by my physical condition. I understand that all programs or activities in which I participate are at my own risk. No CampOut representative shall be liable to any member, nor any other person or guest of a member, for any claims, demands, injuries, damages, actions or causes of action whatsoever, arising out of or connected with the use by the member of the services and facilities of CampOut. The member does hereby forever release and discharge CampOut and all representatives from all claims, demands, injuries, damages, actions or causes of actions, and from all claims of active or passive negligence on the part of CampOut, its servants, agents, or employees. The member agrees to indemnify CampOut against any claims by her children, family and/or guests. The member's waiver of liability claims will survive the termination of this agreement.
